We advance this mission through high-quality research, analysis, citizen education, and coalition building. MECEP is an independent, nonpartisan organization.

4a (Code:) (Expenses \$ 377,321 including grants of \$) (Revenue \$ 490) RESEARCH & EDUCATION - MECEP's main project is its overall effort on helping Maine people prosper in a strong, fair, and sustainable economy through research, analysis, citizen education, and coalition building. Towards this end, in 2013, MECEP produced 13 research reports on topics including health care, tax fairness, property tax relief, education funding, bonds, revenue options, GED, tourism investment, and job growth and productivity. MECEP produced 26 position papers on these matters before the legislature, issues 29 press releases, wrote 15 op-eds, and had its research quoted in 81 newspaper or radio stories. We hosted a public affairs television series which aired 23 shows, maintained a weekly blog and daily Facebook and Twitter sites, and presented information at 15 public events.

4b (Code:) (Expenses \$ 7,638 including grants of \$ 7,138) (Revenue \$ 0) ENGAGE MAINE - was, from 2007 through early 2013, a collaboration of Maine organizations committed to common progressive goals and to making Maine a better place by engaging citizens to play an active role in democracy. This particular manifestation of the effort was discontinued in spring 2013. MECEP was a host organization to this effort, primarily overseeing the expenses of Fundraising, Financial Reporting, and Program consultation services. EM was a non-partisan effort for advancing progressive public policies for a better future for Mainers. The only 2013 activity was a \$7,138 Grant Out, which could more precisely be described as a transfer of Engage Maine project funds from MECEP to another 501c3 host organization for Engage Maine project use.
