"Honoring veterans cannot occur only when politically convenient," MECEP graduate intern and Iraq war veteran Hal Brewster writes in the conclusion his new report ([Honoring Maine Veterans: Serving Better Those Who Served](#)) for MECEP. "A politician should not be allowed to don the yellow ribbon one day and then cut programs the next without having to answer for the very real impact the decision will have on veterans. A strong safety net and robust low-income programs are good for the economy and good for the people of Maine-veteran and nonveteran alike."

The report presents findings from research and analysis of the state programs and services Maine provides to its 129,000 veterans. It recommends five policy changes to improve access, eligibility, and benefit levels for health care, nutrition assistance, higher education, and housing support for our veterans.




Maine Veterans by Age, 2013

Budget and Taxes: Heading for an Endgame?

More than Half of Governor LePage's \$292 Million Tax Cut Would Accrue to Maine Families with Annual Incomes over \$134K

This legislative session began with Gov. LePage unveiling [sweeping proposals for radical changes](#) to Maine's tax system including income, [sales](#), corporate, and [estate taxes](#). MECEP has carefully [examined and analyzed the substantial shortcomings in the governor's plan](#). When legislative Democrats unveiled their counter proposal ([A Better Deal for Maine](#)), MECEP provided [similar analysis](#). The Democrats' plan garnered [strong support from the state's major newspapers](#).

More recently, the discussion turned to the governor's even more contentious proposal to amend the Maine Constitution to repeal the income tax entirely. MECEP mounted a full frontal assault on this ["reckless gimmick that would have put funding for schools and other vital services at risk."](#)

In widely read and circulated blog posts (see below), MECEP outlined [five compelling reasons why repealing Maine's income tax is a very bad idea](#) and the [three "unsavory" alternatives available to pay for the cost of totally eliminating the income tax](#). On May 13, the Joint Committee on Taxation



Is the goal of a college education eluding Maine's aspiring low-income children and their parents? A new MECEP report ([Maine's College Affordability Crisis](#)) finds that "Maine's rate of degree-holding young adults lags the nation, while our graduates struggle with one of the highest student debt loads in the U.S. Low-income working students take on the most debt."

To address this disturbing trend MECEP recommends that legislators expand the State of Maine Grant program to fund all of Maine's neediest students at a rate of \$5,500 per year, increase state appropriations for the University of Maine system to reduce the net cost of attending public college in Maine, and improve funding to the Maine Community College System to make it more responsive to student and workforce demand.

MECEP has shared our findings with legislators, and [action is still pending on promising college affordability initiatives](#).

Fix Maine's EITC to Reward Work and

Reduce Poverty

In a report released on April 27 ([Fix Maine's EITC to Reward Work and Reduce Poverty](#)), MECEP documents how the earned income tax credit (EITC) reduces poverty, promotes work, and, for children in low-income working families, increases lifetime earnings. The report focuses on Maine's state EITC, providing data to demonstrate how legislators can improve it significantly.



MECEP recommends that the legislature make the state EITC refundable and increase its value to 20% of the federal credit. These steps would move Maine closer to the middle of the pack among states that have their own EITCs. The legislature is considering bills to change the state EITC, and [MECEP's report has helped to inform the discussion](#).
