Governor's budget: missed opportunities

Earlier in January, MECEP completed an analysis of the governor's proposed budget and called on legislators to reject it. The governor's plan would give new tax breaks to the wealthy while stripping funding from our schools, shift more costs onto Maine communities while eroding public services we depend on, and increase taxes on low- and middle-income Mainers. In fact, the plan would be a boon for the Top 1% while 80% of Maine families would pay more in taxes.

ACA repeal would be a disaster for Maine


As Congress considers dismantling the Affordable Care Act, MECEP quantified the disastrous harm that repeal would have for Maine families, hospitals, and businesses.



A repeal would cause 95,000 Mainers to lose their health insurance coverage, many of them getting coverage for the first time. It would increase insurance premiums, harming local businesses. It would triple uncompensated care for hospitals and threaten health care jobs in Maine.

Repealing the law without a replacement would roll back lifesaving progress made in the past few years.
