

### Maine Forfeits Over \$1.9 Billion in Federal Funds Under LePage Administration

MECEP's latest report identifies over \$1.9 billion in federal funding that the state of Maine has turned away over the past seven years denying families and businesses the ability to prosper.

Many of the forfeited federal funds are for state priorities, like addressing Maine's opioid addiction epidemic, helping elderly Mainers suffering from Alzheimer's and their caregivers, supporting victims of domestic abuse, and maintaining roadways for efficient commerce. The funds would also provide children with food, health care, and early education; giving them the early healthy start they need to thrive as adults. Forfeiting these federal dollars is causing lasting harm to Maine's people and economy.

MECEP encourages lawmakers to use available federal funds to invest in public health, education, health care, and infrastructure. It also recommends a public inquiry into state government's pursuit and expenditure of federal funding to make sure there are no irregularities.

# Homestead Exemption Elimination Would Raise Property Taxes for Tens of Thousands of Mainers

Governor LePage's budget proposal offers tax breaks worth \$23,000 annually to Maine's top 1 percent, while asking homeowners to pay an average of \$300 more in property taxes.

The budget proposes elimination of the homestead exemption for Maine homeowners under the age of 65.

The exemption provides vital relief from already historically-high property taxes. MECEP created an interactive map that shows the impact of the homestead exemption repeal on each Maine community.







