Notes

Except as noted below, data are from the United States Census Bureau, American Community Survey. The figures represent five-year estimates averaging the period from 2014 through 2018.

Taxable retail sales estimates are based on data from Maine Revenue Services. Change in sales compares total taxable sales in a one-year period from October 2018 through September 2019 with the equivalent 12-month period ending September 2014. Sales data are collected by "economic summary areas," which do not align exactly with legislative districts. For some districts, data were combined from multiple ESAs.

EITC data are from the United States Internal Revenue Service, as compiled by the Brookings Institution. Counts are for tax year 2014 (the most recent available). See brookings.edu/interactives/earned-income-tax-credit-eitc-interactive-and-resources/.

Rates of food insecurity are for 2017. They were estimated using American Community Survey data on district demographics and economic condition, following a methodology used by *Feeding America*. See <u>feedingamerica.org/research/map-the-meal-gap/how-we-got-the-map-data</u>.
